To Whom It May Concern,

Upon reviewing staffing needs for the 2025 November General Election, the Onondaga County Board of Elections would like to propose alternative staffing for all 147 of our polling places. More voters using alternative voting methods such as Vote by Mail and Early Voting, anticipated turnout, and the adoption of Knowink Poll Prints, Knowink Poll Pads, and the Clear Mark and Clear Cast voting systems combine to allow us to serve voters in a more efficient manner. This letter and attached spreadsheet shall serve as our alternative staffing plan in accordance with Election Law 3-500 and 4-104(8).

#### **Voters eligible for November General Election**

All active voters will be eligible to vote in the November General Election. Total voter registration at time of writing this plan is 332,983 voters of which 312,747 are active.

#### **Historical Turnout for similar elections in Onondaga County**

Onondaga County generally has averaged 32.48% turnout for Odd-year Elections over the last three odd-year elections. In 2023 we had 29.64% turnout. In 2021 we had 31.08% turnout. In 2019 we had 36.73% turnout. We expect a similar turnout in the 2025 general election. Over the last three odd-year elections we have had the following voter breakdown: 2023 90,721 votes cast with 72,937 in person on election day (80.40%), 12,681 cast during Early Vote (13.98%), and 5,103 cast by mail (5.62%). 2021 94,306 votes cast with 78,570 in person on election day (83.31%), 9,721 cast during Early Vote (10.31%), and 6,015 cast by mail (6.38%). 2019 107,550 votes cast with 95,300 in person on election day (88.61%), 8,462 cast during Early Vote (7.87%), and 3,788 cast by mail (3.52%).

While it is unclear at this moment if these ratios will hold for 2024, we do believe in person Early Voting will increase while mail in voting, despite the new voting method will level off or decrease.

### **Poll Print and Poll Pad usage in each site**

Onondaga County has recently invested in the Clear Cast voting system as well as expanding our use of Knowink Poll Print on-demand printers. We now deploy Poll Prints and Poll Pads at every poll site in Onondaga County. This reduces the need for multiple ballot tables as inspectors are trained to match the Election District off the receipt to the printed election district on the ballot as it prints off the Poll Print on demand printer. Emergency stubbed ballots are deployed to each site and backup printers are ready to be deployed from our center office. We also have the ability to print in house additional stubbed ballots in the case of several printer failures on Election Day.

### **Staffing Breakdowns by type of polling place**

For the 2025 General Election we have five different types of polling places based on voter enrollment. Super (>3.5k voters), Large (2.0-3.5k voters), Regular (1k-2k voters), Small (500-1k voters) and Micro (<500 voters). We also have 10 Early Voting sites which are the same as in 2023. At every poll site we will dedicate a check in table and ballot table. Election inspectors will check-in the voters via the poll pad and give the voter a receipt. The voter then turns in the receipt at the ballot table to retrieve the ballot that is printed on the Poll print On-Demand printer matching the corresponding election district. Bi partisan oversight will be at both the check in table as well as ballot table and maintained throughout setup and closing procedures.

Super polling sites (12 sites, over 3.5k voters) will have 2 Poll Site Managers and 6 regular inspectors, and 4 poll pads assigned to them, along with 2 Poll Print units. 2 Clear Cast scanners and 1 BMD will be assigned to the site. They will have a separate check in and ballot tables. A Poll Site manager will be stationed at the Check in table with 3 Inspectors. 1 inspector will be at the ballot table along with the 2<sup>nd</sup> poll site manager, 1 inspector will monitor the Clear Cast Scanners, 1 inspector will gatekeep the line.

Large polling sites (64 sites, 2k-3.5k voters) will have 2 Poll Site Managers and 75 regular inspectors and 3 poll pads along with a Poll Print unit. 1 Clear Cast scanner and 1 BMD will be assigned to the site. They will have a separate check in and ballot tables. A Poll Site manager will be stationed at the Check in table with 2 Inspectors. 1 inspector will be at the ballot table along with the 2<sup>nd</sup> poll site manager, 1 inspector will monitor the Clear Cast Scanners, 1 inspector will gatekeep the line.

Regular polling sites (59 sites, 1k-2k voters) will have 2 Poll Site Managers and 4 regular inspectors, and 2 poll pads assigned to them along with a Poll Print unit. 1 Clear Cast scanners and 1 BMD will be assigned to the site. They will have a separate check in and ballot tables. A Poll Site manager will be stationed at the Check in table with 2 Inspectors. 1 inspector will be at the ballot table along with the 2<sup>nd</sup> poll site manager, 1 inspector will monitor the Clear Cast Scanners.

Small polling sites (9 sites, 500-1k voters) will have 2 Poll Site Managers and 3 Additional regular inspectors, and 2 poll Pads assigned to them along with a Poll Print unit. 1 Clear Cast scanners and 1 BMD will be assigned to the site. They will have a separate check in and ballot tables. A Poll Site manager will be stationed at the Check in table with 1 Inspector. 1 inspector will be at the ballot table along with the 2<sup>nd</sup> poll site manager, 1 inspector will monitor the Clear Cast Scanners and 1 will gatekeep the line.

Micro polling sites (2 sites, less than 500 voters) will have 2 Poll Site Managers and 2 regular inspectors, and 2 poll Pads assigned to them. 1 Clear Cast scanners and 1 BMD will be assigned to the site and a Poll Print Unit. They will have one table that will be a combined check-in and ballot table. 2 Poll Site managers will be stationed at the Check in table with 1 Inspector. 1 inspector will monitor the Clear Cast Scanners.

Our Early Voting sites (10) will have 1 of our Custodian at each voting center. They will act as the Poll Site manager of the site. In addition, 2 inspectors who are normally Poll Site managers as well as 4 regular inspectors will be assigned to each site. Each site will have 5 poll pads assigned to it with 4 being designated for check in and 1 being designated as an affidavit only poll pad. 2 Clear Cast scanners and 1 BMD will be assigned to the site. They will have a separate check in and ballot tables. The Custodians will be stationed at the ballot table with the

5<sup>th</sup> poll pad to handle affidavit balloting. One of the poll Site Managers will be stationed at the check in table and one at the ballot table. 2 additional inspectors will be at the check-in table. 1 inspector will monitor the scanners and 1 will gatekeep the line. If additional resources are needed to adjust to wait times, we have substitutes and backups ready to be deployed. These sites will have two dedicated poll print units.

### **Wait times in past presidential elections using similar staffing**

Wait times using similar staffing structure in 2023 and 2021 produced less than 2-minute wait times on average (2023 2:10 2021 1:33). In addition, we have attached a spreadsheet outlining the supplies, inspector quantities, and voter enrollment for each polling site. Average processing time for all elections are 33 seconds at the poll pad. We should allow for double that for the printers to print the ballot and the voter to receive it and be ready to cast a ballot.

### **Battery Backups and emergency stubbed ballots.**

All our Clear Cast Go scanners and BMDS have battery backups that retested and charged at time of deployment which is rated from 2-4 hours of use. Each Poll print has a battery backup in it for use in case of emergency. We also have 40 smaller battery backup units also ready to be deployed for longer outages.

We will print 10% stubbed ballot emergency backup ballots for all polling sites that have a poll print unit assigned to it. We also have our county print shop on standby with the ability to print supplemental emergency stubbed ballots. We have used this system in past elections to deal with temporary and longer-term polling outages. We also will have extra Kyocera printers available to be driven to any site that experiences a catastrophic failure.
