Notes and Definitions:
Risk Assessment 1= Trees that are currently healthy and pose no risk to public or private targets if dead
Risk Assessment 2= Trees that could fall and cause damage to public or private targets if dead
Risk Assessment 3= Trees that have poor health and may cause damage to public or private property regardless of the presence of EAB infestation

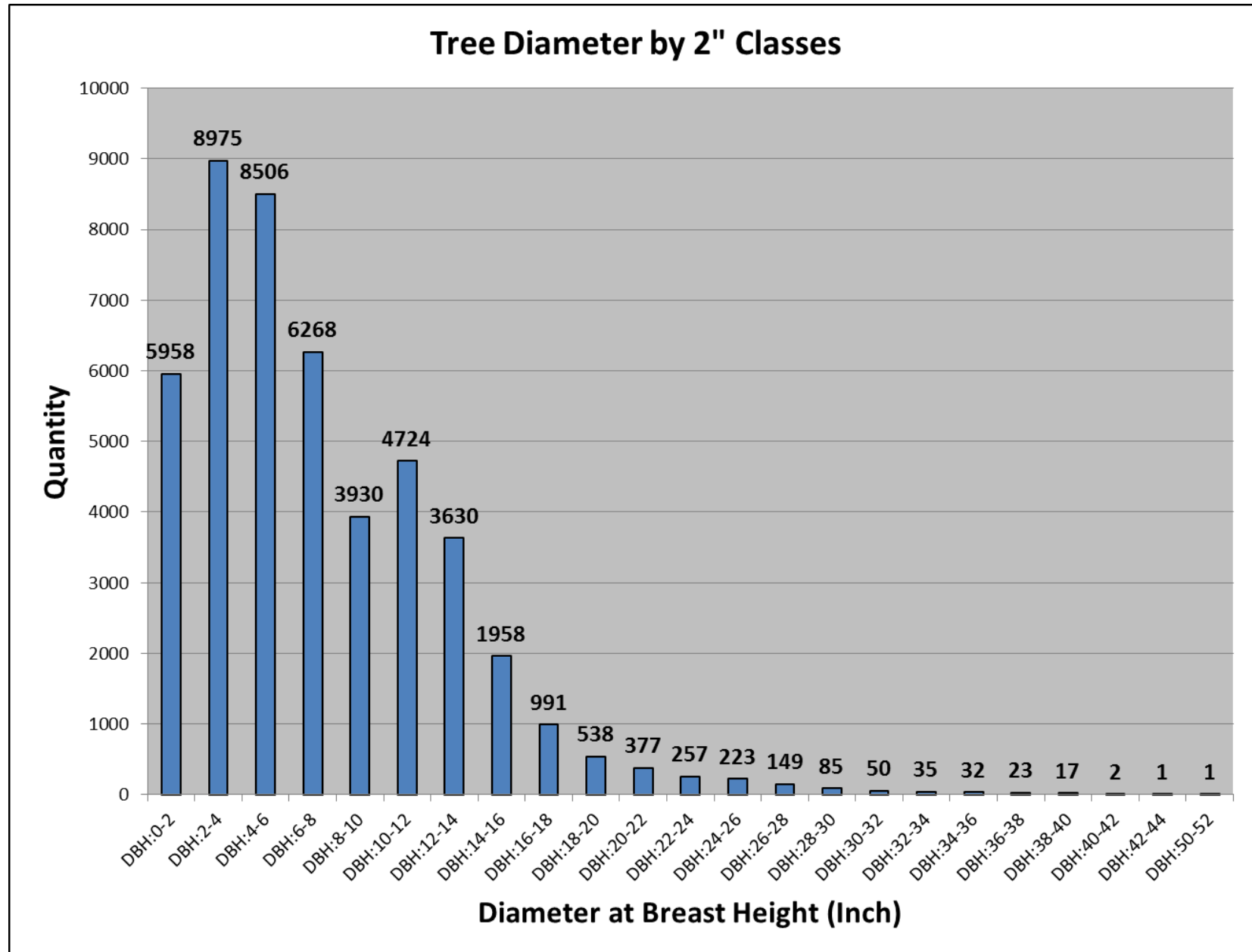
Target: Person, property, or infrastructure that may be damaged from fallen trees

1st Priority Removal= Trees inventoried with a risk assessment of 3 (risk of falling regardless of EAB presence)
2nd Priority Removal= Trees inventoried with a risk assessment of 2, but do not qualify for inoculation due to health condition. These are trees that have a health rating of "B" or "C"

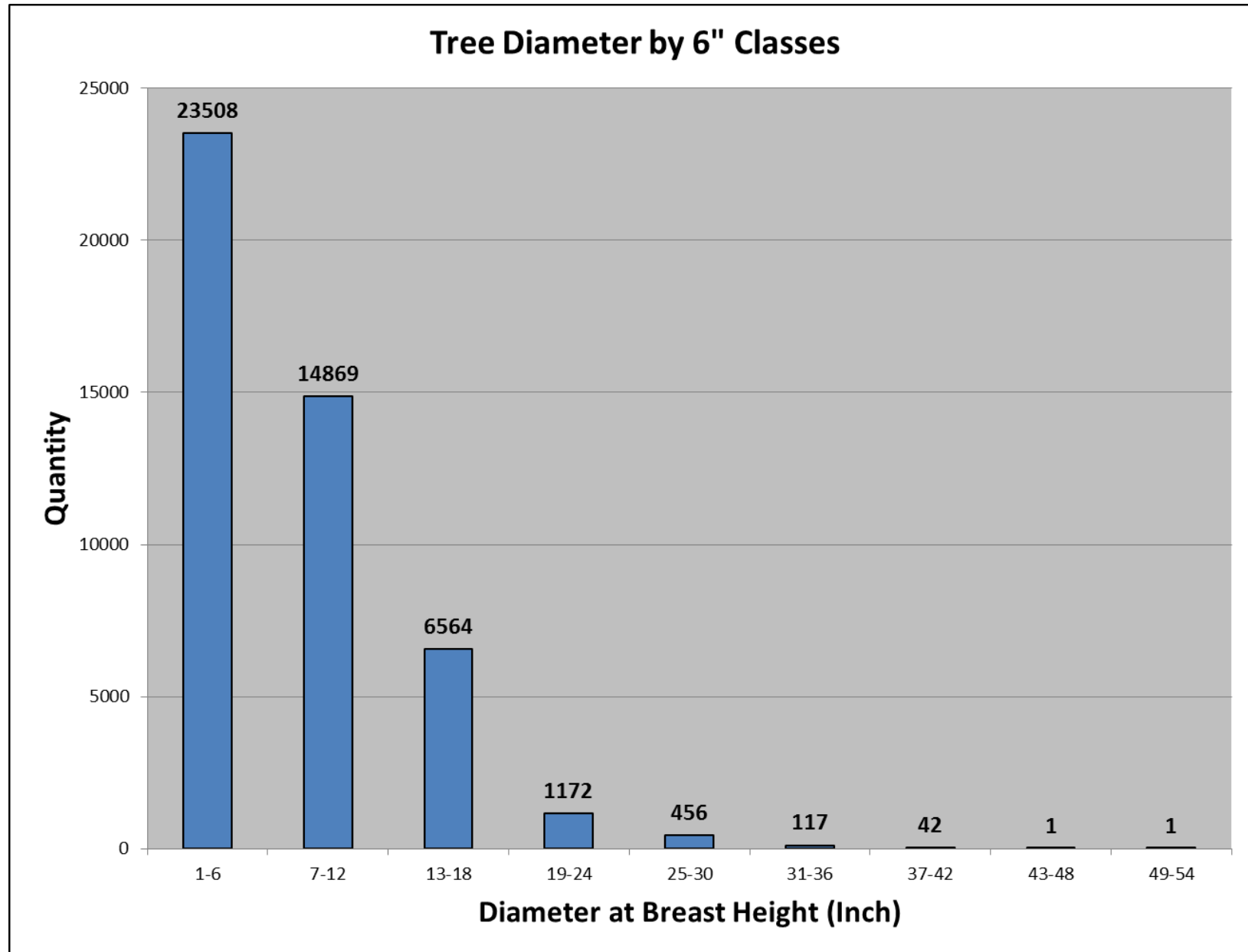
Conservative Inoculation= All trees that are Risk 1 (perfectly healthy) and trees that are Risk 2 that have a health assessment of 1A or 2A
Intensive Inoculation= Trees with a risk assessment 2 with health assessments of 1B or 2B

Health Comments:
1= Stem
2= Canopy
A= Small amount of dead branches or rot
B= Medium amount of dead branches or rot
C= Large amount of dead branches or rot (greater than 40% decay/rot in canopy of tree)
