Follow up: Commissioner Harvey gave an update on his visit to the Summer Open House event at Asha Laaya farm. Harvey reported how the HRC can collaborate with Law Enforcement agencies the state and various agencies and people as it relates to people with disabilities, people with limited English proficiency and people who are deaf or people who are blind. Commissioner McCray noted that she has experience setting up trainings with law enforcement agencies, which can be a hard thing to do.
