Here are the takeaways:

- An idea: Make the event Zoom accessible or livestream.
- It was suggested: Livestreaming the event might be better.
- Media alert – Can we do that, sending out a press release, a 30 second ad?
- Ask the organization to join the conversation. Have organizations invite their network.
- Agnes wants to have a table at the next HRC forum; she was also asked to speak at law enforcement events that are coming up in 2026.
- Commissioner Mary Grace gave an overview of the police/community forum.
- Commissioners should have taken a picture at the Oct. 22<sup>nd</sup> forum.
- Event should have been advertised much better; needs much better marketing.
- Sticky notes soliciting comments/feedback from forum participants is a good idea – mw
- Everyone agreed Mary Grace was superb as moderator. She has been designated as the moderate ad infinitum.
- Agnes realized there is trust between law enforcement officials, the HRC and community. She added it felt like the law enforcement officials were connected to the HRC.
- HRC should put the word out and partner with other for the next public event – mw
- HRC should set a precedent and determine who the target audience will be.
- We were prepared for the community; Commissioner Almandrez did well as moderator
- Commissioner Mary Grace appreciated the Law Enforcement officials awareness of the lack of diversity in certain spaces.
