## HEALTH & HUMAN SERVICES COMMITTEE MINUTES – OCTOBER 17, 2023 COLLEEN A. GUNNIP, CHAIR

MEMBERS PRESENT: Dr. Chase, Ms. Kuhn, Dr. Kelly, Mr. Bush

Chair Gunnip called the meeting to order at 10:28 a.m. The minutes of the previous meeting had been distributed, and there were no objections to waiving the reading. There were no corrections to the minutes, and the minutes were approved.

- 1. HEALTH: Michelle Mignano, Deputy Commissioner
  - a. 2023 Transfer Resolution (\$250,000)
- Requesting a transfer from 101 to 408
  - o Has been corrected for the 2024 budget
  - o Will be long-term dependent on contract Pathologists for weekend and holiday coverage
- Chief Medical Examiner (ME) and Director of Operations are continuously recruiting

## **Questions/comments from the Committee:**

- Has there been conversation about hiring on the 101 line specifically for weekends and/or holidays?
  - o No because there is a solid foundation of contractors
    - Contractor availability tends to be on weekends and extended into holidays
  - Need people currently on the payroll in the middle of the week
- Weekends and holidays are more intermittent?
- No regular needs on weekends?
  - o The department is 24/7
  - Do not look at 101 for coverage, contractors are accessible on weekends and holidays
    - Many contractors work in other ME offices

### **Additional comments from Health Department:**

- Hiring on the 101 is challenging; it is PhD level work
  - Have 4 open positions for Forensic Pathologists

A motion was made by Dr. Chase to approve this item.

## Additional question from the Committee:

- Is the Health Department actively recruiting Pathologists?
  - Yes, continuously recruiting
  - Would be recruiting even if fully staffed

Mr. Bush seconded the motion. Passed unanimously; MOTION CARRIED.

## Background and progress of Road to Emmaus Ministry of Syracuse, Inc.

#### 2009

- Began as an outreach ministry of St. James Church located on the south side under the direction of Father John Manno
  - Augmented Catholic Charities' existing programs, primarily at shelters for men and women, and Bishop Foery Foundation

#### 2012 - 2015

• Expanded into a mobile ministry for those in need throughout the south side neighborhoods, encampments, and under bridges

#### 2016

- Incorporated as a 501 c (3) on April 15
  - Opened the St. Marianne Cope Center for Outreach at 4335 S. Salina Street, providing meals, showers, food pantry, children's activities

#### 2019

- 127 E. Glen property was donated to Emmaus Ministry
  - The buildout was completed, and we opened for service on December 23

## 2020 - 2022

 Fully operational through COVID without incidence of outbreak while accommodating the massive increase in meals needed in the community

#### 2021 - 2022

- Purchased prior outreach center at 4335 S. Salina Street and opened a free dental clinic in August 2022
- Purcell's Paint 4400 S. Salina Street was donated to Emmaus Ministry development projected out to 2025-2026

## 2023

- Medical Clinic at 4335 S. Salina Street opened May 2023
- Currently waiting on the city for our building permit to break ground for the expansion to the 127 E. Glen property to accommodate growing meal service and children's programming along with case management services
- 2019-2022 meals served
  - $\circ$  2019 12,000
  - $\circ$  2020 34,000
  - $\circ$  2021 57,000
  - $\circ$  2022 66.000
- Dr. Strife is the Dental Director
- Dr. David Mason is the Medical Director
- Will be adding 4,000 square feet to E. Glen property for confidential meeting offices, dining, and programming

## **Questions/comments from the Committee:**

- How many people do you see for medical and dental?
  - o 360 Dental; many Ukrainian refugees
  - o 60 Medical; local to 13205 zip code

## **Questions/comments from the Committee:**

- Where does the funding come from?
  - o Primary funding from foundations, private donations, National Grid
  - o Conducted 2 capital campaigns
  - o Have never received money from Catholic Charities or the Diocese

- Are most of your volunteers from various parishes?
  - o Yes
- Do you have liaisons from the Health Department you work with and county social services to help with case management?
  - o Yes
  - o Mary Radford (Emmaus Caseworker) would like to thank Jennifer Robinson from Onondaga County Department of Social Services for helping her get to the right people
- Deputy County Executive of Human Services was introduced as a contact to assist Emmaus with possible funding opportunities
- From case management standpoint, is there any longitudinal follow up to see the effects of treatment referrals?
  - Yes, almost every day
  - o Ongoing relationships while guests come for meals and other services
- Do you have veterans?
  - o Have about 20-25 veterans on a regular basis for meals
  - O Veteran guests are very quiet, not many seek services other than dental
  - o Dental not advantageous through the VA
- Besides Caseworker, do you have people that specifically provide mental health and addiction therapy?
  - o Direct them to Helio Health for drug addiction and arrange for transportation
  - o Well aware of available services and have regular communication with Helio Health and Liberty Resources
- Do you have an informal connection with My Father's Kitchen?
  - o Know of their work
- This is an amazing program; cannot believe what has been accomplished in less than 20 years
- Are you near the valley?
  - Yes, 4 blocks up from Seneca Turnpike
- Do most clients reside in 13205 zip code?
  - O Yes; some from 13207, some from the Northside
  - o Do not ask questions or request registration in order to receive services
- Blessing Box pantry (Lodi/Burnet) is open on Sunday for anyone, no questions asked; would be a good referral source

- 3. <u>ADAM LEVINE & ELIZABETH DAY</u>: Adam Levine, Associate Professor of Health Policy Management at Johns Hopkins; Elizabeth Day, Researcher at University of Oregon, Cornell Project 2Gen
  - a. INFORMATIONAL: Services & Research

Chair Gunnip stated that the Commissioner of Child & Family Services previously met with and provided Onondaga County policies and procedures to Mr. Levine and Ms. Day.

## Mr. Levine presented the following:

- Partner with NYS Association of Counties (NYSAC)
- Purpose is to connect child and family research and policy to Upstate NY counties
  - o Can provide short, tailored research briefs on a wide variety of topics
- Work is funded by William T. Grant foundation
- Service is free to the county
- Grant is almost up, will hopefully get extended

## Ms. Day presented the following:

- Focus on whole family perspective to research policy and practice to assist decision makers
- Have met with many decision makers throughout Upstate NY counties discussing issues with youth and families
  - o Biggest issues include:
    - Youth mental health
    - Child care (including workforce, education)
    - Retention and morale of Caseworkers
    - Grandparents raising grandchildren
- County policy makers can request specific research topics or ask what other counties may be doing
