## WAYS & MEANS COMMITTEE MINUTES – OCTOBER 25, 2022 BRIAN F. MAY, CHAIRMAN

Chair May called the meeting to order at 11:45 a.m. The minutes of the previous meeting had been distributed, and there were no objections to waiving the reading. There were no corrections to the minutes, and the minutes were approved.

## 1. BOARD OF ELECTIONS:

a. Reappointing Michele L. Sardo as Republican Commissioner of Elections

A motion was made by Mr. Olson, seconded by Mr. Burtis, to approve this item. Passed unanimously; MOTION CARRIED.

b. Reappointing Dustin M. Czarny as Democratic Commissioner of Elections (Sponsored by Mr. Ryan)

A motion was made by Mr. Ryan, seconded by Mrs. Ervin, to approve this item. Passed unanimously; MOTION CARRIED.

- 2. **INFORMATION TECHNOLOGY:** Kevin Sexton, Chief Information Officer
  - a. Authorizing Execution of an Intergovernmental Agreement with New York State for Endpoint Protection and Response Services (Sponsored by Mr. Burtis)
- Agreement with NYS JSOC (Joint Security Operations Center) offering programs benefiting local agencies across NYS starting with counties; hopefully will trickle down to towns and villages
- First offer is EDR (Endpoint Protection Services) already use the product, CrowdStrike
  - o Works very well for IT, costs over \$100,000 annually
  - o Entering agreement will allow county to fall under NYS JSOC licensing agreement, saving money for county
  - o Will bring same rules to new tenant; very little lift other than basic coordination
  - Need approval from Legislature and signature from NYS
- Describe endpoint protection
  - o Virus, malware and ransomware protection
  - O Anything that comes through and gets ingested or executed by PCs, laptops and servers
  - Most compromises come through email
  - o Kicks off activity on a PC, starts running malicious software across network, visiting malicious sites
  - o Most destructive being ransomware
  - o EDR is 1 tool in security environment that works to prevent threats and risk to county network
  - o This resolution allows IT to keep doing what they are doing today, but under NYS licensing agreement
- Is CrowdStrike the best product for EDR?
  - o IT feels it is; evaluated quite a few programs
  - Originally used Microsoft's Defender Microsoft came a long way; run both programs alongside each other

- o Technologies for Crowdstrike cause far less disruption than Cylance (used previoulsy)
- o Prevent 0 based strikes key to strengthening environment
- o Identifies new based on malicious activities and network traffic; more sophisticated than older reactive technology
- Would CNYRIC BOCES benefit?
  - o Believe there is opportunity there; NYS looking to get other local agencies at some point; will look into it
- How much will the county save?
  - o Currently spend \$130,000/year; only thing missing from NYS agreement is 24/7 monitoring; will keep that in place and have to pay, so roughly \$100,000 in savings

A motion was made by Mr. Kinne, seconded by Mrs. Ervin, to approve this item. Passed unanimously; MOTION CARRIED.

## 3. WATER ENVIRONMENT PROTECTION: Shannon Harty, Commissioner

- a. Authorizing the Execution of Agreements with the City of Syracuse for Incorporation of Green Infrastructure within Specific Road Reconstruction Projects (\$1,025,000) (Sponsored by Ms. Abbott)
- Program and partnership with city of Syracuse to jointly construct infrastructure with road construction program
- 2<sup>nd</sup> amendment to 2018 IMA
- City will construct green infrastructure on county's behalf, county will reimburse contract cost when bid out
- Last year awarded funding for Water Street Project \$625,000
  - o Project had significant supply chain cost issues, city had to rebid and costs came back over the original amount
- Seeking to do 2 things:
  - o Increase funding for Water Street project, get work installed and completed
  - o Authorization for new joint project on Lodi, part of city's 2023 Road Reconstruction program
- Total amendment is \$1.025M under original IMA
  - o All funded out of ACJ project; original bond resolutions currently have \$7.8M
- Routine practice to optimize efforts of both municipalities to get work done

A motion was made by Mr. Kinne, seconded by Mr. Olson, to approve this item.

- \$575,000 on top of \$625,000 is only for Water Street project
  - o Mostly related to plastic pipe and materials; significant increase; \$7.8M in Clinton Street project
- 3 project accounts in ACJ program; ~\$15M available for ACJ CSO programs in city urban area
  - o \$7.8M Clinton sewer shed; \$6.3M Midland sewer shed; remaining \$500,000 Harbor Brook sewer shed
  - o Point is to capture storm water before it gets in the system

Passed unanimously; MOTION CARRIED.

#### 4. COUNTY LEGISLATURE:

a. Standard Work Day and Reporting Resolution

A motion was made by Mr. Ryan, seconded by Mr. Olson, to approve this item. Passed unanimously; MOTION CARRIED.

The meeting was adjourned at 11:57 a.m.
