Please be advised that as of January 1, 2023, Naphcare will no longer be providing healthcare services for the County facilities. On that date, Wellpath healthcare providers will be assuming duties of these services.

Wellpath is a previous provider of these services for the County and has a prior track record in many facilities in the State, as well as having previous experience with Onondaga County.

Wellpath has been on site and started transitioning as of early December.

A few thoughts that I shared with you this morning:

Training of Officers: those from the JC who would do the “training” were originally trained by the Officers at Jamesville.

**WE** were not notified of the statements concerning the news on Friday before that news was released to tv stations at around 10:00 am and some people with cell phones read the announcements. Telephones started ringing and the noon news then made statements. It just seems that a much better way to handle this proposition would have been to let us know prior, before the general public was informed. For several years there have been rumors concerning this possible closure, but they have been rumors only. Was any consideration given to so many people and staff who work here or are affiliated with Jamesville?

The chaplains here are very different from Jail Ministry. We are not volunteers and our hours are very different as well. Parking could be a problem - the distance, and the cost of parking could enter in. Is it not true that drugs are more prevalent at the JC? More situations and troubles occur there.

The cost of building Jamesville was brought up, but no mention was made about the Justice Center construction, or the work that has been done, or would need to be done. A lot of expenses – a 4<sup>th</sup> tower needed for expansion – most likely.

Now something else that is a concern – what about seniority for our Officers? For instance, if someone is here for many, many years they might not get same days off as Officers who may have worked at the JC for only a year!! Really disturbing! Forcing Officers to go to the JC seems like a punishment.

And finally, how sad it is that only Republican legislators were informed. This is a fact announced by Republicans. What about the Democrats that are legislators – they count, too. What happened there?

(I don't think God is too happy with Onondaga County right now).

WHEREAS, such easement is located immediately adjacent to an existing utility corridor along Taylor Road, in the Town of Dewitt, County of Onondaga (the "County"), and New York State, identified on tax maps of the County as Section 089 Block 01 Lot 01.1 (SBL# 089.-01-01.1) (the "Easement Area"); and

WHEREAS, the Easement Area is twenty (20) feet in width throughout its extent, as depicted in Exhibit A to the Grant of Easement Document on file with the Clerk of the Legislature; now, therefore be it

RESOLVED, that an Environmental Assessment Form (EAF) for the proposed action has been prepared and reviewed, and is on file with the Clerk of the Legislature; and, be it further

RESOLVED, that the EAF prepared by the County and filed with this Legislature is satisfactory with respect to scope, content and adequacy in conformance with to the State Environmental Quality Review Act (SEQRA), and is hereby accepted and adopted by the County; and, be it further

RESOLVED, that this Onondaga County Legislature does hereby accept and adopt the Negative Declaration, prepared in accordance with Article 8 of the Environmental Conservation Law, for the Unlisted Action and has determined that such action will not have a significant adverse impact on the environment; and, be it further

RESOLVED, that the County grants to Niagara Mohawk Power Company and Verizon a permanent nonexclusive easement and right of way through, over, across, under and upon the Easement Area (the "Easement"); for the agreed upon price of One Dollar (\$1) for the Easement, fee waived; and, be it further

RESOLVED, that the County Executive, or his designee, is hereby authorized to execute agreements and such other documents as may reasonably be needed in furtherance of implementing the intent of this resolution.





## GRANT OF EASEMENT

COUNTY OF ONONDAGA, a municipal corporation of the State of New York, having an address at **6660 East Seneca Turnpike, Jamesville, New York 13078** (hereinafter referred to as “Grantor”), is the owner of that certain parcel of real property commonly known as **6660 East Seneca Turnpike (FL 93)** located in the Town of **Dewitt**, County of **Onondaga** in the State of New York, identified on the tax maps of the County of **Onondaga**, as Section **089** Block **01** Lot **01.1** (SBL# **089.-01-01.1**) and pursuant to that certain deed recorded with the County Clerk of the County of **Onondaga** on **06/30/1948** in Liber **1338** at Page **58** (the “Grantor’s Land”), and Grantor, for consideration in the amount of One Dollar (\$1.00) and other valuable considerations, the receipt and sufficiency of which are hereby acknowledged, hereby grants to **NIAGARA MOHAWK POWER CORPORATION**, a New York corporation, having an address at 300 Erie Boulevard West, Syracuse, New York 13202 and **VERIZON**, having an address at 1095 Avenue of the Americas, New York, New York 10036 (hereinafter collectively referred to as “Grantees”), for Grantees and their lessees, licensees, successors, and assigns a perpetual and nonexclusive easement and right of way through, over, across, under and upon the Grantor’s Land (the “Easement”) under the following terms and conditions.

**Section 1 – Description of the Easement.** The Easement provides the Grantees with the right, privilege, and authority to:

a. construct, reconstruct, relocate, extend, repair, maintain, operate, inspect, patrol, and, at their pleasure, remove any poles or lines of poles, supporting structures, cables, crossarms, overhead and underground wires, guys, guy stubs, insulators, transformers, braces, fittings, foundations, anchors, lateral service lines, communications facilities, and other fixtures and appurtenances (collectively, the “Facilities”), which the Grantees shall require now and from time to time, for the transmission and distribution of high and low voltage electric current and for the purpose of transmitting intelligence and communication data, by any means, whether now existing or hereafter devised, for public or private use, in, through, upon, over, under, and across that certain portion of the Grantor’s Land described in Section 2 below (the “Easement Area”), and any highways abutting or running through the Grantor’s Land, and to renew, replace, remove, add to, and otherwise change the Facilities and each and every part thereof and the location thereof within the Easement Area, and utilize the Facilities within the Easement Area for the purpose of providing service to the Grantor and others; and

b. from time to time, without further payment therefor, to clear the Easement Area of obstructions or structures, and clear and keep cleared the Easement Area by physical and/or mechanical means, of any and all brush, trees, limbs, branches, roots, vegetation, or other obstructions; and

c. from time to time, without further payment therefor, to clear and keep cleared by physical and/or mechanical means, the Grantor’s Land beyond the bounds of the Easement Area, of any and all trees, limbs, branches, roots or vegetation that, in the sole judgment of the Grantees, due to species or structural defects or their tall growing nature, are likely to fall into or encroach upon the Easement Area or interfere in any way with the safe and reliable operation of Grantees’ existing or proposed Facilities; and

d. excavate or change the grade of the Grantor’s Land as is reasonable, necessary, and proper for any and all purposes described in this Easement; provided, however, that the Grantees will, upon completion of the work, backfill and restore any excavated areas to reasonably the same condition as existed prior to such excavation; and

e. pass and repass on foot and with vehicles and equipment, along, over, across and upon the Easement Area and the Grantor’s Land in order to access the Easement Area and construct, reconstruct, relocate, use, and maintain roads, paths, causeways, and ways of access to and from the Easement Area as is reasonable and necessary in order to exercise to the fullest extent the Easement.

**Section 2 – Location of the Easement Area.** The “Easement Area” shall consist of a portion of the Grantor’s Land twenty (20) feet in width throughout its extent, the centerline of the Easement Area being the centerline of the Facilities. The general location of the Easement Area is shown on the sketch entitled, “**Easement Sketch-Exhibit A, WR# 11-22-30590532**”, which sketch is attached hereto as Exhibit A and recorded herewith. The final and definitive location(s) of the Easement Area shall become established by and upon the final installation and erection of the Facilities by the Grantees in substantial compliance with Exhibit A hereto.

**Section 3 – Facilities Ownership.** It is agreed that the Facilities shall remain the property of the Grantees, their successors and assigns.

**Section 4 – General Provisions.** The Grantor, for itself, its heirs, legal representatives, successors, and assigns, hereby covenants and agrees with the Grantees that no act will be permitted within the Easement Area which is inconsistent with the Easement hereby granted; no buildings or structures, or replacements thereof or additions thereto, swimming pools, or obstructions will be erected or constructed above or below grade within the Easement Area; no trees shall be grown, cultivated, or harvested, and no excavating, mining, or blasting shall be undertaken within the Easement Area without the prior written consent of the Grantees; the Easement shall not be modified nor the Easement Area relocated by the Grantor without the Grantees’ prior written consent; the present grade or ground level of the Easement Area will not be changed by excavation or filling; the Grantees shall quietly enjoy the Grantor’s Land; and the Grantor will forever warrant title to the Grantor’s Land.

The Grantees, their successors and assigns, are hereby expressly given and granted the right to assign this Easement, or any part thereof, or interest therein, and the same shall be divisible between or among two or more owners, as to any right or rights created hereunder, so that each assignee or owner shall have the full right, privilege, and authority herein granted, to be owned and enjoyed either in common or severally. This Grant of Easement shall at all times be deemed to be and shall be a continuing covenant running with the Grantor’s Land and shall inure to and be binding upon the successors, heirs, legal representatives, and assigns of the parties named in this Grant of Easement.



WHEREAS, the Syracuse-Onondaga County Planning Agency has completed a Plan under the guidance of the Onondaga County Agricultural and Farmland Protection Board, with additional input and in-kind services from the Cornell Cooperative Extension of Onondaga County and the Onondaga County Soil and Water Conservation District; and

WHEREAS, the County Agricultural and Farmland Protection Board held a series of focus groups, stakeholder meetings and public meetings during Plan development, developed a public website to solicit input and review of materials relative to the Plan, and solicited comments and has incorporated those comments in the Plan; and

WHEREAS, this County Legislature and the County Agricultural and Farmland Protection Board held a public hearing on the Plan on December 20, 2022 at 12:50 p.m., prior to which the Plan was made available to the farm community for their comments and input; and

WHEREAS, approval of the Plan by the County Legislature, and subsequent approval by the Commissioner of Agriculture and Markets, shall make Onondaga County's Agricultural and Farmland Protection Board eligible for state assistance payments for the implementation of approved farmland protection plans pursuant to Article 25AAA of the New York State Agriculture and Markets Law; now, therefore be it

RESOLVED, that the proposed action is an Unlisted Action pursuant to the New York State Environmental Quality Review Act (SEQRA); and, be it further

WHEREAS, new owners and investors involved in the Project developed a plan for construction of a three-story mixed-use building to include 12,000 square feet of retail space and 32 apartments—with 25% committed as affordable housing units. Accordingly, by creating taxable retail space and much needed affordable fully accessible residential units, the Project will benefit the village's tax base and meet community need; and

## BOND RESOLUTION

A RESOLUTION AUTHORIZING THE RECONSTRUCTION AND EXPANSION OF THE WHITNEY APPLIED TECHNOLOGY CENTER AT OCC TO CREATE A MICRON CLEANROOM IN AND FOR THE COUNTY OF ONONDAGA, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$10,000,000, AND AUTHORIZING THE ISSUANCE OF \$5,000,000 BONDS OF SAID COUNTY TO PAY COSTS THEREOF

BE IT RESOLVED, by the affirmative vote of not less than two-thirds of the total voting strength of the County Legislature of the County of Onondaga, New York, as follows:

Section 1. The reconstruction and expansion of the Whitney Applied Technology Center at OCC to create a Micron Cleanroom, including furnishings, equipment and incidental costs and expenses, is hereby authorized in and for the County of Onondaga, New York, at a maximum estimated cost of \$10,000,000.

Section 2. The plan for the financing thereof is by the issuance of \$5,000,000 bonds of said County, hereby authorized to be issued therefor pursuant to the provisions of the Local Finance Law, and by the application of \$5,000,000 State grants to be received in connection therewith.

Section 3. It is hereby determined that the period of probable usefulness of the aforesaid specific object or purpose is twenty-five years pursuant to subdivision 12(a)(1) of paragraph a of Section 11.00 of the Local Finance Law.

Section 4. The faith and credit of said County of Onondaga, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. To the extent not available from other sources, there shall annually be levied on all the taxable real property of said County a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable.

Section 5. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the bonds herein authorized, including renewals of such notes, is hereby delegated to the Chief Fiscal Officer of such County. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Chief Fiscal Officer, consistent with the provisions of the Local Finance Law.

Section 6. All other matters except as provided herein relating to the bonds herein authorized including the date, denominations, maturities and interest payment dates, within the limitations prescribed herein and the manner of execution of the same, including the consolidation with other issues, and also the ability to issue bonds with substantially level or declining annual debt service, shall be determined by the Chief Fiscal Officer, the chief fiscal officer of such County. Such bonds shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law, and shall otherwise be in such form and contain such recitals, in addition to those required by Section 51.00 of the Local Finance Law, as the Chief Fiscal Officer shall determine consistent with the provisions of the Local Finance Law.

Section 7. The County Executive is authorized to enter into contracts to implement the intent of this resolution. In the event that General Fund Operating Surplus Funds are available at the end of the fiscal year, and if the Chief Fiscal Officer of Onondaga County deems it fiscally advantageous to use surplus funds rather than borrowing, all or a portion of the cost of the improvements authorized herein shall be paid using such surplus funds. Further, in the event that General Fund Operating Surplus Funds are so utilized, then the authorization to issue bonds provided within this resolution is hereby rescinded accordingly, reduced by the amount of funds utilized.

Section 8. The validity of such bonds and bond anticipation notes may be contested only if:


- 1) Such obligations are authorized for an object or purpose for which said County is not authorized to expend money, or
- 2) The provisions of law which should be complied with the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or
- 3) Such obligations are authorized in violation of the provisions of the Constitution.

Section 9. This resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150-2. Other than as specified in this resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long-term basis, or otherwise set aside with respect to the permanent funding of the object or purpose described herein.

Section 10. This resolution, which takes effect immediately, shall be published in summary form in the Syracuse Post Standard, the official newspaper of said County, together with a notice of the Clerk of the County Legislature in substantially the form provided in Section 81.00 of the Local Finance Law.
