Manatee County, Florida, is in a state of emergency and residents are being evacuated as a toxic wastewater reservoir is on the brink of collapse, and Gov. Ron DeSantis said crews are working to prevent "a real catastrophic flood situation."

Families in at least 316 homes were ordered to evacuate Saturday after officials warned that Piney Point Reservoir, about 40 miles south of Tampa, could flood homes with 15 to 20 feet of water if it collapses.

The reservoir holds a mix of saltwater, fresh water, wastewater and fertilizer runoff. DeSantis clarified Sunday that the water is not radioactive after concerns were raised because the ponds are in stacks of phosphogypsum, a solid radioactive byproduct of manufacturing fertilizer.

I have attached this to be entered into comments. Comments to the Committee based on Kelo vs New London:

Kelo v. City of New London, 545 U.S. 469 (2005), was a case decided by the Supreme Court of the United States involving the use of eminent domain to transfer land from one private owner to another private owner to further economic development. In a 5–4 decision, the Court held that the general benefits a community enjoyed from economic growth qualified private redevelopment plans as a permissible "public use" under the Takings Clause of the Fifth Amendment.[1]

The case arose in the context of condemnation by the city of New London, Connecticut, of privately owned real property, so that it could be used as part of a "comprehensive redevelopment plan." After the Court's decision, the city allowed a private developer to proceed with its plans; however, the developer was unable to obtain financing and abandoned the project, and the contested land remained an undeveloped empty lot in 2021.

The United States Supreme Court granted certiorari to consider questions raised in Berman v. Parker, 348 U.S. 26 (1954) and later in Hawaii Housing Authority v. Midkiff, 467 U.S. 229 (1984). Namely, whether a "public purpose" constitutes a "public use" for purposes of the Fifth Amendment's Taking Clause: "nor shall private property be taken for public use, without just compensation." Specifically, does the Fifth Amendment, applicable to the states through the Due Process Clause of the Fourteenth Amendment (see main article: Incorporation of the Bill of Rights), protect landowners from takings for economic development, rather than, as in Berman, for the elimination of slums and blight?

Dissenting opinions

The principal dissent was issued on June 25, 2005 by Justice O'Connor, joined by Chief Justice Rehnquist and Justices Scalia and Thomas. The dissenting opinion suggested that the use of this taking power in a reverse Robin Hood fashion—take from the poor, give to the rich—would become the norm, not the exception:

Any property may now be taken for the benefit of another private party, but the fallout from this decision will not be random. The beneficiaries are likely to be those citizens with disproportionate influence and power in the political process, including large corporations and development firms. [9]

O'Connor argued that the decision eliminates "any distinction between private and public use of property—and thereby effectively delete[s] the words 'for public use' from the Takings Clause of the Fifth Amendment."[10]

Thomas also issued a separate originalist dissent, in which he argued that the precedents the court's decision relied upon were flawed. He accuses the majority of replacing the Fifth Amendment's "Public Use" clause with a very different "public purpose" test:

This deferential shift in phraseology enables the Court to hold, against all common sense, that a costly urban-renewal project whose stated purpose is a vague promise of new jobs and increased tax revenue, but which is also suspiciously agreeable to the Pfizer Corporation, is for a 'public use.'[11]

Thomas additionally observed:

Something has gone seriously awry with this Court's interpretation of the Constitution. Though citizens are safe from the government in their homes, the homes themselves are not.[12]

Thomas also made use of the argument presented in the NAACP/AARP/SCLC/SJLS amicus brief on behalf of three low-income residents' groups fighting redevelopment in New Jersey, noting:

Allowing the government to take property solely for public purposes is bad enough, but extending the concept of public purpose to encompass any economically beneficial goal guarantees that these losses will fall disproportionately on poor communities. Those communities are not only systematically less likely to put their lands to the highest and best social use, but are also the least politically powerful.[13]

In spite of repeated efforts, the redeveloper (who stood to get a 91-acre (370,000 m2) waterfront tract

of land for \$1 per year)[citation needed] was unable to obtain financing, and the redevelopment project was abandoned. As of the beginning of 2010, the original Kelo property was a vacant lot, generating no tax revenue for the city.[2] In the aftermath of 2011's Hurricane Irene, the now-closed New London redevelopment area was turned into a dump for storm debris such as tree branches and other vegetation.[19]

Pfizer, whose employees were supposed to be the clientele of the Fort Trumbull redevelopment project, completed its merger with Wyeth, resulting in a consolidation of research facilities of the two companies. Pfizer chose to retain the Groton campus on the east side of the Thames River, closing its New London facility in late 2010 with a loss of over 1,000 jobs. That coincided with the expiration of tax breaks on the New London site that would have increased Pfizer's property tax bill by almost 400 percent.[20][21]

After the Pfizer announcement, the San Francisco Chronicle, in November 2009, in its lead editorial called the Kelo decision infamous:

The well-laid plans of redevelopers, however, did not pan out. The land where Susette Kelo's little pink house once stood remains undeveloped. The proposed hotel-retail-condo "urban village" has not been built. And earlier this month, Pfizer Inc. announced that it is closing the \$350 million research center in New London that was the anchor for the New London redevelopment plan, and will be relocating some 1,500 jobs.[22]

The Chronicle editorial quoted from The New York Times:

"They stole our home for economic development," ousted homeowner Michael Cristofaro told the New York Times. "It was all for Pfizer, and now they get up and walk away." [22]

The final cost to the city and state for the purchase and bulldozing of the formerly privately held property was \$78 million.[23] The promised 3,169 new jobs and \$1.2 million a year in tax revenues had not materialized. As of 2021, the area remains an empty lot.

In 2008, land use Professor Daniel R. Mandelker argued that the public backlash against Kelo is rooted in the historical deficiencies of urban renewal legislation.[36] In particular, the article cited the failure to incorporate land use planning and a precise definition of blight in urban renewal legislation as problematic. In 2009, Professor Edward J. Lopez of San Jose State University studied passed laws and found that states with more economic freedom, greater value of new housing construction, and less racial and income inequality were more likely to have enacted stronger restrictions sooner.[37]

Severe criticism of the Kelo decision came from Professor Gideon Kanner of the Loyola Law School, Los Angeles.[38] Kanner wrote, "The principal failing of the Kelo decision is that it misreads the case law on which it purports to rely as a seminal precedent, and by its holding frustrates the usual mode of constitutional analysis."[39] He likened the language in the majority's decision ("'public' means 'private' and 'use' means 'purpose,' or 'prognosticated municipal prosperity'") to the abuse of language in George Orwell's Nineteen Eighty-Four.[40]

State legislation

Prior to Kelo, eight states specifically prohibited the use of eminent domain for economic development except to eliminate blight: Arkansas, Florida, Kansas, Kentucky, Maine, New Hampshire, South Carolina and Washington.[41] As of April 2019, 45 states had enacted some type of reform legislation in response to the Kelo decision.[30] Of those states, 22 enacted laws that severely inhibited the takings allowed by the Kelo decision, while the rest enacted laws that place some limits on the power of municipalities to invoke eminent domain for economic development. The remaining five states have not passed laws to limit the power of eminent domain for economic development.[37][42]

California

Under pre-existing California law, takings (for conveyance to a private party, as opposed to a public use that may incidentally benefit private parties) were already illegal.

Proposition 90, which attempted to exploit the unpopularity of Kelo for a different objective, failed in the November 2006 election.[43] The initiative also included language requiring that government pay financial compensation to any property owners who could successfully argue that regulation caused them significant economic loss. Subsequently, Proposition 99 passed in the June 2008 election. It amends the state constitution to prohibit (subject to some exceptions):

state and local governments from using eminent domain to acquire an owner-occupied residence [if the owner has occupied the residence for at least one year], as defined, for conveyance to a private person or business entity.

In 2012, California abolished its redevelopment agencies.[44]

Kansas

In response to the Kelo decision, the Kansas Legislature enacted K.S.A. 26-501a and K.S.A. 26-501b and amended K.S.A. 26-501.

K.S.A. 26-501a. Eminent domain; limited to public use; transfer to private entity prohibited; exception. On and after July 1, 2007: (a) Private property shall not be taken by eminent domain except for public use and private property shall not be taken without just compensation. (b) The taking of private property by eminent domain for the purpose of selling, leasing or otherwise transferring such property to any private entity is prohibited except as provided in K.S.A. 2009 Supp. 26–501b, and amendments thereto. (c) This section shall be part of and supplemental to the eminent domain procedure act. History: L. 2006, ch. 192, § 1; May 25.

Michigan

Michigan passed a restriction on the use of eminent domain in November 2006, Proposition 4, 80% to 20%.[50] The text of the ballot initiative was as follows:[51]

A proposed constitutional amendment to prohibit government from taking private property by eminent

domain for certain private purposes

The proposed constitutional amendment would:

Prohibit government from taking private property for transfer to another private individual or business for purposes of economic development or increasing tax revenue.

Preserve existing rights of property owner


Minnesota


The state restricts eminent domain to public use. Minnesota Statute 117.025 Subd. 11(b) (passed in 2006) clearly states: "The public benefits of economic development, including an increase in tax base, tax revenues, employment, or general economic health, do not by themselves constitute a public use or public purpose."[52]

Legacy

The block of land at the heart of the case, adjacent to Fort Trumbull, still stood vacant as of April 2018.[67]

OCIDA's EIS on White Pine states that they will use Eminent Domain to acquire the Burnet Road properties if necessary. They have already been using the threat of eminent domain to intimidate residents into negotiation. OCIDA is determined to purchase or control the entire neighborhood with purchase options, using these funds. Burnet Road residents have said they have been anxious and upset for months because of OCIDA's harrassing phone calls, negotiation "deadlines", and threats of eminent domain.

Just the threat of eminent domain is using the power of eminent domain. OCIDA is forcing sales of private homes for the purpose of land speculation. In June, at a Town of Clay meeting, the County Executive McMahon, was careful to define the "project" as the expansion of the park, as opposed to finding an actual tenant. He stated that the Park has no signed tenants at this time. Without a tenant, the land will likely sit idle, perhaps for years, and family homes and farms will have been taken with no benefit to the public.

WHEREAS, by Resolution No. 77-2021, the Onondaga County Legislature called for a public hearing to be held on July 15, 2021 at 6:00 p.m. for fiscal year 2019 respectively, in the Legislative Chambers in the Onondaga County Courthouse pursuant to Section 209 of the New York State Civil Service Law, and said hearing was duly held as scheduled at which the Commissioner of Personnel appeared on behalf of the Employer and explained the Employer's respective positions on the Factfinder's report and recommendations and the President, Incumbent President and Representative appeared on behalf of the DSBA to further explain their position on the report and recommendations; and

WHEREAS, the Onondaga County Legislature has considered the Factfinder's Report and Recommendation, as well as the explanations of the respective positions on the report and recommendations, to arrive at what it deems to be a resolution to the impasse that is in the best interests of the public, including the interests of the public employees involved; now, therefore be it

RESOLVED, that after the above-described hearing and deliberation, in order to resolve the impasse in negotiations for fiscal year 2019, the Onondaga County Legislature hereby imposes the terms and conditions contained in the collective bargaining agreement between the County of Onondaga and the DSBA that expired on December 31, 2018 for fiscal year 2019 with no changes except as specifically stated below; and, be it further

RESOLVED, that after the above-described hearing and deliberation, in order to resolve the impasse in negotiations for fiscal year 2019, the Onondaga County Legislature hereby increases by 2%, effective with the beginning of the first full payroll period after January 1, 2019, the "2018 Salary Schedule F" and the "2018 Overtime Rates/Schedule C" contained in Article 30 of the collective bargaining agreement between the County of Onondaga and the DSBA that expired on December 31, 2018.

MEMORIALIZING RESOLUTION IN SUPPORT OF REQUESTING COMMERCIAL MOTOR VEHICLES TO BE MANDATED TO USE A GLOBAL POSITIONING SYSTEM (GPS) THAT ACCOUNTS FOR LOW BRIDGES AND OVERPASSES

WHEREAS, "commercial motor vehicle" includes tractor-trailers, buses, tall rental trucks used for hauling, construction trucks, and any other vehicle used for commercial purposes; and

WHEREAS, New York State averages 220 bridge strikes per year due to over-height commercial vehicles that result in injuries to drivers, other motorists, costly repairs to bridges, traffic disruptions, and harm to highway infrastructure; and

WHEREAS, New York State spends around \$15 million per year to repair bridge strikes; and

WHEREAS, according to the Federal Motor Carrier Safety Administration, GPS devices designed for commercial-use provides important information to drivers that they would not receive if using a non-commercial GPS device, such as information on low bridges and overpasses; and

WHEREAS, in 2018, New York State issued guidelines urging insurers to encourage commercial auto policy-holders to utilize GPS systems that specifically warn truck drivers and bus operators of height restrictions on New York roads; and

WHEREAS, New York State has spent \$4.3 million to prevent vehicles from striking low-bridges around New York City by installing infrared beam systems that identify an over-height vehicle on a roadway with a low bridge, and then posts an alert message for the driver on an electronic sign along the roadway, warning them to leave before encountering the hazard; and

WHEREAS, at some locations, drivers of over-height vehicles have stated that the warning from the infrared system comes too late to offer sufficient time to exit a highway; and

WHEREAS, the Trucking Association of New York stated that GPS devices designed for commercial-use is preferrable because some drivers are from out-of-state, and thus are unfamiliar with New York roads and where the infrared systems may be located; and

WHEREAS, utilizing GPS devices designed for commerical-use is more financially responsible for New York State than expending millions of dollars on infrared systems only to cover a few bridges in the New York City metro-area; and

WHEREAS, GPS devices designed for commercial-use offer a better warning for the driver, ensures every bridge can be accounted for, and will better improve road safety across New York to protect highway infrastructure; now, therefore be it

RESOLVED, that this Onondaga County Legislature hereby requests that the New York State Legislature mandate the use of commercial global positioning systems on commercial motor vehicles for the safety of motorists, New York State roadways, and to protect highway infrastructure; and, be it further

RESOLVED, that the Clerk of this Legislature is hereby directed to cause a copy of this resolution to be transmitted to the New York State Legislators representing Onondaga County.

WHEREAS, The Onondaga County Industrial Development Agency (OCIDA) is a public benefit corporation of the State of New York created in 1970 pursuant to Article 18-A of the General Municipal Law; and

WHEREAS, OCIDA is authorized to advance the job opportunities, health, general prosperity and economic welfare of the people of Onondaga County and improve their recreation opportunities, prosperity and standard of living, as well as, promote, develop, encourage, and assist in the acquiring, constructing, reconstructing, improving, maintaining, equipping and furnishing of industrial, manufacturing, warehousing, commercial, research, recreational, education, cultural, railroad, and horse racing facilities; and

WHEREAS, OCIDA's mission is to stimulate economic development, growth, and general prosperity for the people of Onondaga County by using available incentives, rights, and general powers in an efficient and cooperative manner; and

WHEREAS, OCIDA operating funds are derived solely from fees paid by applicants seeking assistance, closed OCIDA projects (which create new capital investment), and interest earned on the OCIDA Fund Balance; and

WHEREAS, OCIDA provides business support and operates incentive programs consistent with its powers and mission statement in the following areas: Financing – Tax-exempt private activity bonds, taxable bonds and Quasi-Equity Loan Fund participation; Tax Management – Exemptions from mortgage recording, sales and use taxes and abatement of real property taxes through payment-in-lieu of tax agreements; Training Support – Service contracts for company specific employee training and skills assessment programs consistent with its Employee Productivity Program guidelines; and Asset Development – Development of property and facilities for investment; and

WHEREAS, in order to help OCIDA promote and stimulate economic development in Onondaga County, this Legislature seeks to support these efforts by agreeing to loan OCIDA funds to help to pay for its program incentives, projects, including asset development, and work related improvements, along with, industrial and commercial marketability; now, therefore be it

RESOLVED, in consideration of such benefits, it is the desire of this Onondaga County Legislature to loan OCIDA sufficient funds, on an as-needed basis pursuant to a revolving loan program and in a total amount not to exceed \$20,000,000.00, to expand and improve asset development in Onondaga County in order to enable OCIDA to market these properties to a larger more diverse mix of potential industrial and commercial developers by making various project sites more attractive to a broader scope of industries and bringing high tech and high paying jobs to Onondaga County; and, be it further
